PRICING & OPTIONS:

OPTION 1: NEW OPERATOR TRAINING AT YOUR SITE

This is the right class if you have new operators and need to train them according to OSHA and ANSI standards. If you have existing operators and are unsure of the quality or content of their past training, if you are missing their paperwork or if they were certified through a prior employer, this is the right option. The class includes classroom instruction, written testing and hands-on evaluations for each type of MEWP. Our instructors bring to life the realities of what can happen when MEWP's are not operated safely, operators will leave feeling much different about their role in MEWP safety.

Class size: Minimum billing of 6 operators, maximum class size is 15.

Time frame: 5-8 hours depending on the number of trainees and MEWP types.

Pricing: \$150 per trainee.

OPTION 2: RE-EVALUATION AT YOUR SITE

Our re-evaluation course is geared towards companies with operators which have already been properly trained at your company and are in need of re-evaluation. The class includes one hour of classroom instruction, a written quiz and a hands-on evaluation. Topics such as tip-overs, falls, collisions and electrocutions are covered. Our real-life accident pictures and video clips will remind your operators about the consequences of unsafe actions. It will get the attention of your experienced operators who already know how to operate safely, but may not be applying that knowledge on the job.

Class size: Minimum billing of 6 operators, maximum class size is 15

Time frame: 2-3 hours depending on number of students and equipment types

Pricing: \$110 per person

NOTE: Normal training hours are weekdays from 6AM to 6PM. Saturday and non-standard hour training are available for a \$200 per class additional flat fee. Reasonable travel charges will apply to any operator training conducted outside of Ohio.
